**Provisions of Agreement**

**Lessee agrees to indemnify Lessor and hold Lessor harmless from any and all claims, actions, suits, proceedings, costs, expenses, damages and liabilities, including attorney's fees, arising out of, connected with, or resulting from the equipment or the personnel provided hereunder, including without limitation the manufacture alteration, modification, selection, delivery, possession, use he, conduct or return of said equipment or personnel, unless due to negligence of Lessor. In the event of a accident equipment shall stay on rental every day until repaired and is in working order Lessee shall secure and maintain (a) insurance in an amount not less than that stated on the face hereof against all risks of loss or damage from every cause whatsoever to the equipment rented from Lessor hereunder, and (b) comprehensive general and automobile liability insurance in an amount no less than \$1,000,000.00 combined single limit for personal injury, bodily injury and property damage. This coverage shall include contractual liability covering the specific matter outlined above. The automobile liability shall include non-owned and hired automobiles. Lessee shall provide certificates of insurance, signed by an authorized representative of the subject insurance company, in duplicate, evidencing compliance with the provisions of these requirements. All such policies of insurance shall be in the form and with companies acceptable to Lessor and shall provide that coverage is provided for Lessor as an additional insured, that Lessor shall receive notice in writing from the insurance company at least thirty (30) days prior to a cancellation or reduction of the limits of coverage that the coverage provided for herein is to be primary to all other insurance, and that coverage shall commence at the time the equipment leaves the premises of Lessor and shall remain in full force and effect until returned to these premises. Vendor driver Union and/or Non-Union driver hired by Cinecraft LLC and/or Cinema Rentals of Las Vegas (sub leased) to be covered in this agreement. Evidence of the above insurance requirement must be filed with Lessor. Non-smoking policy. All vehicles are non-smoking vehicles and lessee is responsible for all damages caused from smoking in or near the vehicles. A \$250 per day fee may be charged lessee in addition to the cost to repair any damaged items if the smoking policy is not observed.**
